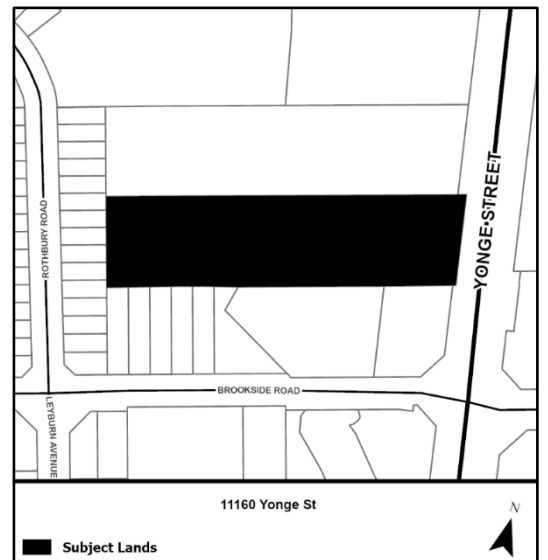


NOTICE OF COMPLETE APPLICATION

The City of Richmond Hill has received a Zoning By-Law Amendment Application to permit a Temporary Use

A request has been received to amend Zoning By-law 190-87, as amended by By-law 12-25 for lands described as Part of Lots 4 and 6, Part of Block A in Plan 1642 and Part 13 of Plan 65R-15221 and municipally known as 11160 Yonge Street. The purpose and effect of the proposed Zoning By-Law Amendment is to permit the temporary uses of a car dealership and a pet care store for a period of no more than 3 years within the existing commercial building on the subject lands.

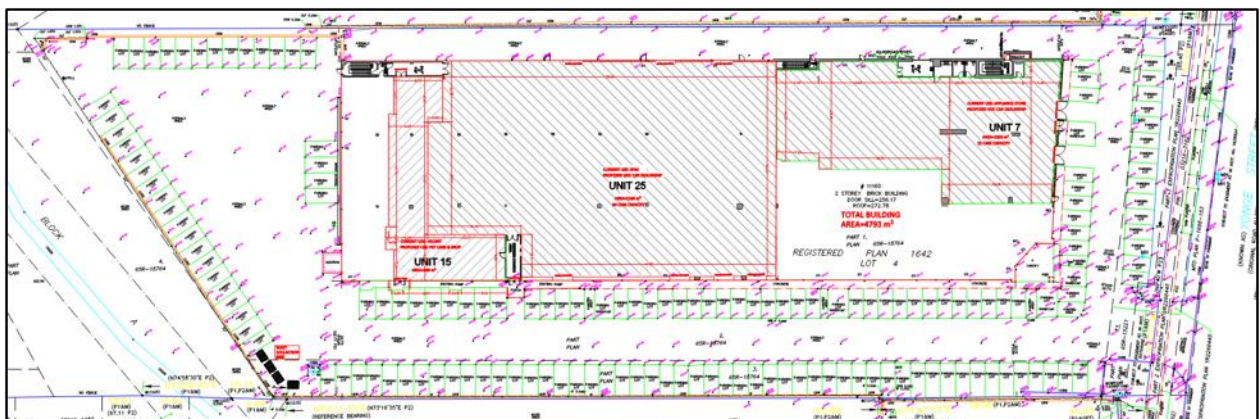
