Take Notice that you are in default of the requirements of *Municipal Elections Act, 1996*, as amended because:

You failed to file your auditor's report in accordance with the requirements of Section 88.25(1) of the *Municipal Elections Act, 1996, as amended*. As a candidate in the 2020 York Region District School Board by-election, you were required to file your auditor's report in the prescribed form with the Clerk on or before 2:00 p.m. Monday, January 4, 2021.

Take Further Notice that in accordance with Section 88.23(2) of the *Municipal Elections Act, 1996* as amended, until the next regular election has taken place, **you are ineligible to be elected or appointed to any office to which the *Municipal Elections Act, 1996*, applies.**

Take Further Notice that the default penalty referred to above does not take effect if **no later than 2 p.m. on Wednesday, February 3, 2021**, 30 days after the eligible day for filing the document (January 4, 2021), a candidate files the relevant document and pays a **late filing fee of \$500** to the Clerk.

In accordance with Section 88.23(3) of the Act, a copy of this Notice of Default must be made public and will be posted to the City of Richmond Hill's website.

Cessation of Penalties - Notice of Default

Whereas on the 5th day of January, 2021, a Notice of Default, pursuant to the requirement of Section 88.23(3) of the *Municipal Elections Act, 1996*, as amended (the "Act"), was issued to you for your failure to file a campaign financial statement and auditor's report (*if required*) in the prescribed form, as required by Section 88.25(1) of the Act, with the Clerk on or before 2:00 p.m. Monday, January 4, 2021 (the "Notice of Default");

And Whereas the Notice of Default notified you that as a result of your failure to file a campaign financial statement and auditor's report (*if required*) in the prescribed form, as required by Section 88.25(1) of the Act, you were, pursuant to Section 88.23(2) of the Act, ineligible to be elected or appointed to any office to which the *Municipal Elections Act, 1996*, applies (the "default penalty");

And Whereas the Notice of Default advised that, pursuant to Section 88.23(9) of the Act, the default penalty does not take effect if no later than 2 p.m. on Wednesday, February 3, 2021, 30 days after the eligible day for filing the document (January 4, 2021), a candidate files the relevant document and pays a late filing fee of \$500 to the Clerk;

And Whereas, on the 28th day of January, 2021, you did file a campaign financial statement and auditor's report (*if required*) in the prescribed form and did pay the late filing fee of \$500.00;

Therefore, pursuant to Section 88.23(9) of the *Municipal Elections Act, 1996*, as amended (the "Act"), the penalty imposed upon you by Section 88.23(2)(b) of the Act, for failure to file a campaign financial statement and auditor's report (*if required*) in the prescribed form, shall not take effect.
